



REQUEST FOR PROPOSAL

TO ESTABLISH MULTI-SUPPLIER FRAMEWORK
AGREEMENTS FOR
QUANTITY SURVEYING SERVICES AT
THE PIARCO INTERNATIONAL AIRPORT AND
THE ANR ROBINSON INTERNATIONAL AIRPORT

Airports Authority of Trinidad and Tobago ("the Authority") invites proposals from suitably qualified individuals or companies/businesses to establish Multi-Supplier Framework Agreements for the provision of **Quantity Surveying Services at the Piarco International Airport and the ANR Robinson International Airport in the following Specialised Areas:**

- a) Specialised Area 1 Civil Infrastructure
- b) Specialised Area 2 Mechanical
- c) Specialised Area 3 Electrical
- d) Specialised Area 4 Plumbing

The RFP Document will be available **Friday 3rd September 2021**. In order to obtain the RFP Document, prospective Proposers must email the Corporate Secretary at corporate_secretary@tntairports.com, on or before **Wednesday 15th September 2021 at 4:00pm AST** with the subject **"Quantity Surveying Services at the Piarco International Airport and the ANR Robinson International Airport"**, requesting the RFP document. The email shall include:

- 4. Representative Telephone contact.

Prospective Proposers are required to attend a **Mandatory Virtual Pre-Proposal Meeting** to acquaint themselves with conditions which may influence their Proposal. The **Mandatory Virtual Pre-Proposal Meeting** is scheduled for **Thursday 16th September 2021 at 10:00am**. Invitations will be emailed to Proposers who have requested the RFP document.

Proposals may be submitted for one or more of the Specialised Areas. Proposers who are desirous of submitting Proposals for more than one Specialised Area, must submit a separate Proposal for each Specialised Area selected.

Proposals must be uploaded in soft copy in Portable Document Format ("PDF") via the link provided by the Authority no later than 2:00pm on Thursday 7th October 2021.

The Authority shall host a virtual public opening thereafter at **2:30 p.m. AST**. Proposers or their representatives may be present at the virtual opening.

LATE PROPOSALS WILL NOT BE CONSIDERED IN ANY CIRCUMSTANCES. Proposals submitted by means of facsimile or email shall not be considered.

A Proposer who participates in or submits more than one Proposal per Specialised Area shall cause all Proposals submitted for that particular Specialised Area to be rejected. A Proposer bidding individually or as a member of a joint venture/consortia arrangement or partnership shall not be entitled to submit another Proposal (for the same Specialised Area) either individually or as a member of any other joint venture/consortia arrangement or partnership.

The Authority will not defray any costs incurred by Proposers during the preparation and/or submission of their Proposals. Failure to attend the Mandatory Virtual Pre-Proposal Meeting will result in the disqualification of the submitted Proposal.

The Authority does not bind itself to accept the lowest or any other Proposal.
