

## **INVITATION TO BID**

## The Supply of the Airfield Lighting Fixtures for the Runway Centreline at the Piarco International Airport

Prospective Bidders are required to attend a **Mandatory Virtual Pre-Bid Meeting** to acquaint themselves with conditions which may influence their Bid. The Mandatory Virtual Pre-Bid Meeting is scheduled for **Monday July 10, 2023 at 10:00 a.m. AST**.

The contract will be awarded in accordance with the pre-defined evaluation criteria and a scoring system outlined in the Invitation to Bid ("ITB") Document. The Airfield Lighting Fixtures will be governed by the terms and conditions outlined in the respective ("ITB") Document.

Bids must be completed and submitted in accordance with the instructions outlined in the ITB Document, and must be accompanied by the Mandatory Documents listed at Section 2.1 of the Submittal Checklist.

Failure to attend the Mandatory Virtual Pre-Bid Meeting will result in disqualification of the submitted Bid.

Failure to comply with any of these instructions or to submit any documentation required in the ITB Document may result in Bids not being considered.

The Authority does not bind itself to accept the lowest or any other Bid.
