# PROCUREMENT NOTICE

## INVITATION TO BID FOR THE SUPPLY AND INSTALLATION OF RETAIL KIOSKS AT THE NEW TERMINAL, ANR ROBINSON INTERNATIONAL AIRPORT

1. The Airports Authority of Trinidad and Tobago ("the Authority") was established by the Airports Authority of Trinidad and Tobago Act Chapter 49:02 of the laws of Trinidad and Tobago and is responsible for the development and management of its airport estates, including the maintenance and improvement of its facilities, so as to ensure the availability of efficient, secure and safe aviation services and commercial viability.
2. The Authority hereby invites suitably qualified firms to submit sealed bids for **THE SUPPLY AND INSTALLATION OF RETAIL KIOSKS AT THE NEW TERMINAL, ANR ROBINSON INTERNATIONAL AIRPORT.**
3. Bidders who wish to participate in this ITB process must be prequalified on the Office of Procurement Regulation's depository under any of the following lines of business:
  - #95141700 – Prefabricated Commercial and Industrial Buildings and Structures
  - #72121102 – Commercial and Office Building Prefabricated Erection Service

5. The Invitation to Bid (ITB) will only be issued electronically, to prequalified providers of the goods and services required, as listed in the Procurement Depository maintained by the Office of Procurement Regulation (OPR).

### Tendering Process

6. Bidder's representatives have the option to either attend the Mandatory Pre-Bid meeting & Non-Mandatory Site Visit Virtually or in Person.
7. The **Mandatory Pre-Bid Meeting and Non-Mandatory Site Visit** is scheduled for Monday 24th March, 2025 at 10:00am (AST) at the **Airport Administration Building, ANR Robinson International Airport. Representatives attending the meeting in person must be outfitted with the necessary Safety Shoes and PPE gear.** The link to attend the meeting virtually can be accessed on the Authority's website at <https://tntairports.com/business/procurement/procurement-opportunities/>.
8. The contract will be awarded in accordance with the pre-defined evaluation criteria and a scoring system outlined in the Invitation to Bid ("ITB") Document, **THE SUPPLY AND INSTALLATION OF RETAIL KIOSKS AT THE NEW TERMINAL, ANR ROBINSON INTERNATIONAL AIRPORT.**
9. Bidders must submit a Bid Security in favour of the Authority marked to the value of **TWENTY-SIX THOUSAND TRINIDAD AND TOBAGO DOLLARS (TT\$26,000.00).** The Bid Security may be either, in the form of a certified manager's cheque or bond (in the Form of Bid Security contained in the Bid document) established with a financial institution incorporated in Trinidad and Tobago and acceptable to the Authority. 10. Bidders must upload the softcopy of their Bid in PDF format by using the designated upload link provided by the Authority. The Bid file must be uploaded with the applicable naming convention in the format:

The deadline for submission of Bids is on **Thursday 24th April, 2025 at 2:00 PM (AST).** Bids will be publicly opened via a virtual meeting in the presence of the Bidders' designated representatives and anyone who chooses to attend, on the same date **Thursday 24th April, 2025 at 2:30 PM (AST).**

13. Bids must be completed and submitted in accordance with the instructions outlined in the bidding document.
